### **Idea and Target**

This seminar aims to improve the scientific research and writing skills of the students. Every student should work on an individual topic, which should contribute a new element to the debate about Corporate Social Responsibility (CSR). This project should be worked out on a strictly scientific basis: solid research in primary and secondary data; proper distinction between description and valuation, careful and intensive citation. This project can be seen as a preparation for the bachelor thesis.

- **B.)** The first chapter (the outline for the work) must be presented in written form and in form of a short presentation (5 min.) and discussion upon appointment in the earlier part of the seminar.
- **C.)** The completed project should also be presented in a short presentation of 10 minutes upon appointment.

This seminar is an elective, not obligatory. You will be allowed to take the next step only if the step before was successful in the planned time (stage-gate process)!

That means: first B.), then C.) and then you will be allowed to hand in the final paper A.).

#### **Project Topics**

It is task of the student to define a suitable project. Depending on the complexity of literature research and content, the presentation will be earlier (easier) or later (more complex). The project can contain: an overview over actual schools and developments in the field of CSR (first presentations), Corporate case studies and best-practise examples, regional economic case studies (both with a special international focus preferred), future trends and developments in

## **Legal Description of "Project Assignment"**

From the BBA Exam Regulation (excerpt):

### Section 19: Project assignment

- (1) A project assignment is a composition generated in the course of a practice-related project. It may be amended with a presentation not longer than 45 minutes, as specified by the lecturer.
- (2) The project assignment may be performed in an establishment inside as well as outside the university if its supervision is ensured. Candidates must be granted the opportunity to make suggestions for the topic of the project assignment.
- (4) The project assignment is set by the supervisor. The set date is the day on which the candidate is informed of the topic. The date has to be placed on record.
- (5) The allocated time (period from the set date to submission of the assignment) shall not exceed three months.
- (6) The written composition of a project assignment shall be submitted to the supervisor at due time. When submitting the project assignment, the candidate must affirm in writing that it was written independently and that exclusively the sources and resources cited were used. The submission time has to be placed on record. If the written part of the project assignment is sent through postal service the time of posting shall be authoritative. If the written part of the project assignment is not submitted in due time, the work will be considered "failed" (5.0).
- (7) The project assignment is assessed based on the written composition and an oral presentation if one was given.
